Major Membership Changes:

After 3 years of really trying to make the membership process work I've come to the decision that, in its current form, it is simply not working and has become an operational nightmare that requires immediate change. While the principals of why I put membership in place are sound, the technology and labor costs required to make this work effectively are currently beyond the leagues reach at the moment.

Let me be clear however, I am NOT abandoning membership for a total return to player cards. I'm removing the individual players ability to sign up on line and putting the responsibility of player membership back into the hands of managers. (Why?) The trouble has been that not all players actually complete membership. Many teams drag their feet for months because they don't want to or can't chase players up to get this process completed. Additionally, the confusion about whom from your team is done and whom we think is done is often not equal. Other issues include; Players insisting they paid and we have no record, missing photo's, missing information, wrong information, etc.. the list is actually pretty extensive. It's added to the work managers do and for the league to get membership cards completed and confirmed. The bottom line is, it's going to be far more efficient and effective if we have the team manager responsible for player cards and the management of them.

As it was before membership, manager's will be responsible in providing the league: A team roster (before each season) and player information as new players join their teams. Namely; Player information, Players picture, Confirmed release of liability and Membership registration fee (We will STILL be requiring an annual registration fees. As before, the fee will be prorated.)

I've created a Manager's Player Membership registration form (included in this package). Which managers will be able to edit. **It will be expected that managers email back this form along with pictures.** (As paper pictures complicate the membership process and take too long to scan/edit and complete, paper submissions for membership cards will include a service charge of \$10 each.) Once the league receives the registration form, we will then send you back a Paypal link to pay for the cards. Only once the payment is complete will we process the membership card(s). The form can be used for adding a many or as few player required. (Basically from 1 to 25 players). You do not need to Add/Drop players.

At this point since MOST of you have your complete membership cards for your team there nothing for you to do unless you're ADDING a player. In which case, you will need to use the Player Membership Registration form.

Also, once the season begins, Team's will no longer be allowed to request a game postponement or reschedule. Schools and City Parks are no longer allowing full refunds or credits unless they receive a minimum of 2 weeks notice. The League can no longer absorb the costs of having to pay for fields a second time.

I'll be making an F.A.Q. about this on line soon. Any and all questions you have are very welcome.

SBASL Release of Liability Statement

In consideration for being permitted to engage in activities related to the South Bay Adult Soccer League ("SBASL") of whatever nature, including but not limited to games, events, projects, activities; and to the fullest extent of the law; I agree to indemnify, defend and hold harmless SBASL, their agents, employees and contractors, from claims, demands, causes of actions and liabilities of every kind and nature whatsoever arising out of or in connection with SBASL's operations.

This indemnification shall extend to claims occurring after my involvement has terminated as well as while it is in force. The indemnity shall apply regardless of any active and/or passive negligent act or omission of SBASL, or their agents, contractors or employees, but I shall not be obligated to indemnify any party or claims arising from the sole negligence of willful misconduct of SBASL or their agents or employees.

The indemnity obligations set forth herein shall apply to both property damage and personal injury in any person, including myself, arising from any activities which are or could be asserted against SBASL as a result of any acts or omissions by myself.

As a member of SBASL I also agree that as I participate in the activities sponsored by the league, including games, I do so at my own risk (i.e. I am assuming the risk of injury and/or damage) and that, I, the member shall be wholly responsible for any injuries or other damage suffered by myself due to said participation in the league activities.
